KHYC to CBYC (Spinnaker #4) FOURTH RACE OF THE KHYC SPINNAKER SERIES First Race of the Around the Point Series Saturday, June 18, 2016

<u>RULES</u> This event will be governed by the 'rules' as defined in the current Racing Rules of Sailing. The prescriptions of USSA and the event Sailing Instructions shall apply. RRS Rule 82 will not apply to this event. This is a US Nearshore event with paragraph 3.8.2 modified to only require any type of VHF radio.

ENTRIES: Spinnaker classes are open to members of SCYA affiliated Yacht Clubs or Associations who hold a current PHRF rating certificate. PHRF Non-Spinnaker offsets will not be applied. Cruisers, Multihulls, Martin 242s, Vipers and other one design classes are invited; at least three entries will constitute a class. Cruising class boats must have a current ASMBYC Cruiser rating. One Design and Multihull entries must fulfill the eligibility requirements of their class. Entrants shall complete the online entry process at http://www.regattanetwork.com/event/12781. Registration can be performed at KHYC from 0900 until 1030 on race day. The entry fee is \$20.00, with a \$3 late fee for entries on race day.

<u>VENUE:</u> This is a point to point race **starting** at KHYC "Y" Mark (Santa Monica Bay) and **finishing** at CB Mark "82" (Los Angeles Harbor). Refer to the current KHYC Race Mark Guide and Event Race Chart, as well as, the Sailing Instructions available at regattanetwork.com and at the Registration Desk on Race Day.

<u>DIVISIONS</u>: PHRF class splits, using PHRF Area-B2 Buoy ratings, are as follows: A (129 and lower) - B (130 and higher). This does not alter the rating protocol used to score this race.

COURSE: Start at Y - 10PV - Pt Vicente Outer Rock - 6PF - Angels Gate - Finish at CB82 about 17 NM.

STARTS: In the vicinity of "Y" mark. The first warning for "B" boats will be at 1155. "B" boats will start at 1200. "A" boats warning will be at 1225, start at 1230. (Note: Other classes will start in the interval between the "B" start at 1200 and the "A" start at 1230). Boats must sail by the RC boat prior to the 1st warning signal for their class in order to be recognized as a starter.

FINISH: The finish will be between a committee boat and the mark CB "82" inside LA Harbor.

PENALTY SYSTEM: Rule 44.1 is changed so that the two turn penalty is replaced by the one turn penalty. Rule 44.3 will not apply.

SCORING: The Low Point scoring system of RRS Appendix A.4 will apply as a single race event. PHRF Regional **OWC** Course ratings will apply with Time-On-Distance scoring for this race. Area ratings do not apply for this race.

TROPHIES: Individual trophies will be awarded at CBYC following the race. The H.A Simms Perpetual trophy for PHRF A & B will be presented at the KHYC annual awards event.

FACILITIES: All participants are welcome at the KHYC Clubhouse before the race. KHYC's galley will be open on the Friday before the race for lunch between 11:30am and 2:00pm and hearty appetizers will be served at the bar from 6:00 to 9:00pm. Saturday morning the galley is open for breakfast beginning at 8:30am. Dinner will be available at CBYC on Saturday night. Please contact Tom Skridge at CBYC regarding the Saturday night dinner.

<u>DOCKING and SLIPS</u>: Participating boats are welcome to use the KHYC overnight guest dock and hoist facilities; the guest dock is available on a first-come, first serve basis. Call the KHYC Office for inquiries concerning the guest dock. Additional slips may be obtained from King Harbor Marina at a discounted overnight rate for registered race participants at (310) 376-6926. Slips at CBYC are available on Saturday for a short-term stay as well as overnight. If you need a berthing following the race, please contact Tom Skridge in advance with your boat length and draft as well as your intention to stay overnight.
