RACE NOTICE AND GENERAL INFORMATION

- 1.0 The racing will be conducted by designated host yacht clubs and organizations located in the Southern California area, and listed in this Notice.
- * Certain classes and fleets will sail on other dates, as indicated in this Notice.
- 2.0 The REGATTA will be governed by the Racing Rules of Sailing 2001-2004, the rules of each class concerned, and the sailing instructions of the host club.
- 3.0 Classes that will race are listed in this notice, and include One Design, Handicap, Model Boats and Windsurfing. Classes not listed in this Notice may apply to the Chairman for assignment to a host club. At least 5 entries are required to establish a class.
- 3.1 One Design and Handicap classes are requested to have an official representative at the host club before or during registration to resolve any matters concerning the class.
- 3.2 The regatta is open to all boats belonging to member yacht clubs of the Southern California Yachting Association, other yacht clubs, Southern California Cruising Association, US Windsurfing Association, American Model Yacht Association, and other recognized associations.
- 3.3 Boats racing in PHRF handicap classes must have a valid/current certificate. Out of the area boats may obtain a guest certificate from the PHRF office, 562-438-6712. Boats in the Cruising Division must have a valid/current PHRF certificate, with a rating of 27 to 192 seconds per mile, and a ULDB factor of 1.80 or less. They must also file a Cruising Division worksheet with their registration.
- 4.0 Registration shall be made by mail to the host club, or in person, before the close of registration listed in this Notice. The entry fee shall be payable to SCYA and collected by the host club at the time of registration. Entry forms as included in this Notice must be complete. Model Boats may use their own entry forms.
- 4.1 Fees depend upon the size of the boat, and will be discounted as listed below for current members of the US SAILING. Non-members will be afforded an opportunity to join US SAILING at the time of registration.
- 4.2 The fees will be:

- 5.0 Sailing Instructions will be published by the host clubs, or organizations, and will be available at the time of registration, or in advance as determined by the host club.
- 6.0 The Host Clubs establish their own registration Deadlines and Starting times as listed in this Notice of Race.
- 7.0 Trophies will be awarded at the host clubs as soon as possible after the final race, according to the following schedule:
